- **Practitioners, students, researchers, and academics** in Oral & Maxillofacial Pathology, Medicine, Radiology, Surgery, and related fields.
- **Dental & Medical Professionals** from head & neck specialties.

## WHAT CAN YOU PRESENT?

- **Single Case Reports:** Rare, complex, or diagnostically/therapeutically challenging cases.
- **Case Series:** Minimum of **three cases** with a common disease, exposure, treatment, or outcome.
- **Diagnostic Innovations Showcase:** 5-minute presentations on new technologies or techniques enhancing diagnosis or management.

## PRESENTATION FORMATS

- **Oral Presentations:** 8-minute pre-recorded presentation followed by live discussion.
- **Poster Presentations:** PDF poster with a 3-minute live presentation and discussion.
- **Diagnostic Innovations Showcase:** 5-minute pre-recorded presentation & live discussion

## ABSTRACT RULES AND GUIDELINES

1. Individuals may present **only one abstract**.
2. Individuals can coauthor multiple abstracts.
3. Presenters and coauthors must agree to the [IODCPC Policies Abstract Licensing Policy](#) during Submission.
4. Abstracts previously published (in print or electronic formats), previously presented, or accepted for presentation at another meeting at the time of abstract Submission are not allowed.
5. The IODCPC reviewers reserve the right to reclassify submitted abstracts into the most appropriate category.
6. Abstracts must be submitted through the online abstract submission site. WhatsApp messages or emailed copies will not be reviewed.
7. You must receive the **approval of all coauthors** before putting their names on the abstract.
8. **Abstracts are reviewed as submitted by the March 15, 2025 abstract deadline.**

IODCPC is an official Oral Pathology 360 program. As such, all legal rights, responsibilities, and considerations outlined in this document apply equally to IODCPC and Oral Pathology 360. By submitting an abstract, presenters, and coauthors acknowledge and agree to comply with all policies governing both IODCPC and Oral Pathology 360.

### PRESENTER AGREEMENT

All presenters must agree to the following conditions when submitting an abstract:

- Affirm that all patient information is anonymized and patient consent has been obtained.
- Affirm that the work has **not** been published (in print or electronically) or presented elsewhere prior to Submission to the IODCPC25 Meeting.
- Agree to pre-register for the meeting and pay the appropriate registration fee by the presenter's pre-registration deadline of March 15, 2025
- By submitting an abstract, presenters agree to participate in the recorded components of **IODCPC25**, which may be used for educational and promotional materials by **both IODCPC and Oral Pathology 360**.

### IODCPC25 ABSTRACT LICENSING POLICY

By choosing to have an abstract included in the abstract book and in consideration for the opportunity to be included in IODCPC25's Abstracts collection, the author of the abstract hereby provides to IODCPC25 and Oral Pathology 360 a non-exclusive, irrevocable, worldwide, royalty-free license to use the abstract in IODCPC25's publications and materials. **Additionally, any materials or content incorporated into IODCPC25's official program, website, or promotional content may also be used by Oral Pathology 360 for educational or promotional purposes under the same licensing terms.**

Authors who wish to exclude their abstract from full-text publication in the conference proceedings must indicate this at the time of Submission.

## IODCPC FULL DISCLOSURE POLICY

**IODCPC and Oral Pathology 360** seek to provide participants with current, scientifically based information relevant to oral and maxillofacial health care. All disclosures, warranties, and intellectual property rights associated with the Submission and presentation of abstracts apply equally to both **IODCPC and Oral Pathology 360**.

Once a presenter is selected for a particular topic, IODCPC does not attempt to control the content of the presentation or any submitted abstract. Therefore, in submitting an abstract for presentation and publication, a presenter represents and warrants to IODCPC that any intellectual property associated with or contained in the content of the abstract or presentation is owned by the presenter or that the presenter is authorized to use said content along with any applicable intellectual property associated with the content.

IODCPC may require a presenter to provide adequate written assurance that the presenter is authorized to use the content of the abstract or presentation. In the event IODCPC requests such written assurance and the presenter fails to provide the requested documentation, the presenter may be denied the ability to make the presentation.

For any abstract or presentation, the presenter and any applicable coauthors of the content must be identified by full name and affiliation. The presenter confirms he has received the approval from the coauthor (s) to have their name(s) associated with the abstract and its content prior to Submission.

The presenter further agrees to indemnify and hold harmless IODCPC from any and all claims of third parties regarding the content of the abstract or presentation, including but not limited to any claims of infringement of intellectual property or misappropriation of proprietary or trade secret information.

In order to ensure fairness to the audience and the public, however, IODCPC requires each presenter and coauthors to disclose:

1. Any financial relationship between the presenter and coauthors and
  - a. A company that manufactures or distributes a product discussed in the presentation, or
  - b. A company whose product competes, or may compete, with a product discussed in the presentation must be disclosed to the IODCPC upon approval on the abstract Form and must be disclosed to the audience at the beginning of the presentation.

As used in this document, "financial relationship" includes a consulting arrangement or conducting research for the company by the presenter or coauthor or a member of the presenter's or coauthor's immediate family. It also includes ownership of stock or other interest in a company by the presenter or coauthor and/or a trust of which the presenter,

coauthor, or a member of the presenter's or coauthor's immediate family is a beneficiary, to the best knowledge of the presenter.

2. All presentations must be made in a professional manner, without disparaging colleagues, companies, or products. Unnecessarily demeaning comments and attacks on colleagues, companies, or products are unacceptable.

Failure to adhere to these guidelines may result in sanctions as deemed appropriate by the IODCPC, including denial of permission to present at future IODCPC meetings.

## PRESENTER CHANGES

If you are unable to attend the meeting and wish to name a substitute presenter, please use the following guidelines:

- The Presenting Author is the only author that may request a presenter change
- The substitute presenter must be a coauthor.
- The substitute presenter must **NOT** be presenting another abstract at the meeting.
- A substitute presenter must be able to present the abstract in assigned presentation mode; after the abstract submission deadline of March 15, 2025, all requests for presenter changes **MUST** be made using the Presenter Change/Withdraw Form (link to be made available after the abstract deadline). Requests made using this Form will be reviewed before processing.
- Substitution requests must be made before April 15, 2025
- All Presenter Changes must be communicated through the required online Form and approved by the IODCPC review board before the presentation.
- Failure to follow the above procedures may result in the presentation not being included and the presenter not being allowed to present at a future meeting.

## WITHDRAWAL OF ABSTRACTS

The following are the guidelines for withdrawing abstracts:

- You may withdraw your abstract at any time until April 15, 2025, using the Presenter Change/Withdraw Form. Requests not submitted via this Form will not be considered.
- All withdrawal requests must be communicated through the required online Form.
- Withdrawals after April 15, 2025, may result in the author being disqualified from submitting abstracts to future IODCPC conferences.

**PLEASE NOTE:** Any submitted incomplete abstract after March 15, 2025, will be withdrawn automatically. The submitting author must ensure the accuracy of the content of the abstract and all coauthors' details. **No changes to the abstract text, including typos, incorrect data, etc., will be permitted after March 15, 2025.**

## PREPARING TO SUBMIT AN ABSTRACT

All abstracts must be submitted online via the IODCPC online abstract submission form. Each completed Submission is peer-reviewed for its content.

### Important Submission Elements

1. **Presenting Author Pre-registration:** In order to complete Submission of an abstract the presenting author must be already registered for the conference.
2. **Abstract Text:**  Use the **Abstracts Template below**- save as a word document

## Abstract Submission Categories & Instructions

### A. Case Presentations (Oral & Poster Presentations)

- The abstract should follow the **standard template** provided above.
- Include **clinical relevance, diagnostic methods, and patient outcomes**.

### Sample Abstract Case Presentation:

Tuberculosis is a common illness for vulnerable populations in resource-limited settings. Lymph nodes in tuberculosis represent the most frequent extrapulmonary form of tuberculosis in children, but lymph nodes are rarely generalized and large. We report an atypical pediatric case of tuberculosis with lymphadenopathy. A two-year-old child with severe acute malnutrition presented with painless, generalized, and excessively large nodes that were not compressive and were without a fistula. Fine needle aspiration was performed and led to the detection of lymph node granulomatous lymphadenitis suggestive of tuberculosis. The child was immediately initiated on antituberculosis therapy with a very successful outcome. Clinicians should be aware of atypical manifestations such as the one we describe in the interest of swift diagnosis and initiation of treatment.

## B. Diagnostic Innovations Showcase (5-Min Oral Presentation)

The **Diagnostic Innovations Showcase** could include

- Novel Imaging Techniques** - e.g., AI-based CBCT interpretation, digital scanning technologies.
- Surgical & Non-Surgical Innovations** - e.g., robotics in oral surgery, guided implant placement.
- Artificial Intelligence & Predictive Diagnostics** - e.g., machine learning models for early detection of diseases.
- Telemedicine & Remote Diagnosis** - e.g., Teledentistry applications.
- Biomarker & Molecular Testing Advances** - e.g., saliva-based diagnostics, molecular profiling.

- The abstract should be written as a **single paragraph (300 words or less)** but **must focus on technology, innovation, or advancements** rather than case details.
- Clearly describe:
  - **Background:** The problem or limitation in current diagnostic/management techniques.
  - **Innovation:** The new technology or approach being introduced.
  - **Clinical Impact:** How the innovation improves diagnosis or patient care.

*Sample Abstract Diagnostic Innovations Showcase:*

Access to specialized oral healthcare remains a challenge in remote and underserved areas, leading to delays in the diagnosis and management of oral conditions. Teledentistry, integrating AI-driven imaging analysis with real-time consultation, presents a solution to bridge this gap. This presentation showcases a **mobile-based teledentistry platform** designed for early detection and triage of oral lesions. The platform enables **primary care providers and general dentists** to capture and upload intraoral images, which are analyzed using **machine learning algorithms** for potential malignancy markers, periodontal disease, and mucosal pathologies. Cases requiring specialist intervention are flagged and remotely reviewed by **oral medicine and maxillofacial surgery teams**, expediting patient referrals. We have used this technology for **6-months on 500 patients** across three rural clinics and found a **40% reduction in diagnostic delays** and a **30% improvement in timely specialist intervention**. The findings highlight the potential of teledentistry to **enhance early detection and streamline referral pathways**, making specialized care more accessible.

## CRITERIA FOR ABSTRACT ACCEPTANCE

Abstracts will be selected for presentation based on the **scientific quality, clarity, and relevance** of the work as assessed by an impartial panel of reviewers. All abstracts are reviewed **in a blinded process**, ensuring fair and unbiased selection based on scientific merit.

As accepted abstracts will be **published and become part of the global scientific literature**, they must be **scientifically sound, well-structured, and grammatically correct**. High standards will be upheld to ensure the quality of the conference program.

### Evaluation Criteria

Each abstract will be assessed based on the following:

#### A. Case Reports & Case Series

1. **Relevance** – Does the case contribute to new insights, educational value, or improved understanding of diagnosis and management?
2. **Clarity of Case Presentation** – Is the case clearly described, including clinical details, diagnosis, and management?
3. **Novelty & Impact** – Does the case present a rare, unusual, or diagnostically/therapeutically challenging scenario?
4. **Scientific Rigor** – Are clinical reasoning and supporting diagnostic procedures clearly outlined?
5. **Compliance with Formatting Guidelines** – Does the abstract adhere to word limits, structure, and anonymity requirements?

#### B. Diagnostic Innovations Showcase

1. **Innovation & Advancement** – Does the abstract describe a new or improved diagnostic or management technique/technology?
2. **Clinical Utility & Relevance** – How does the innovation impact clinical practice, patient outcomes, or workflow efficiency?
3. **Scientific & Technical Validity** – Is the innovation methodology, development process, or validation clearly explained?
4. **Comparative Advantage** – How does this technique or technology improve upon existing diagnostic or management methods?

### Common Reasons for Abstract Rejection

1. The **case details or nature of the innovation** are not explicitly stated in the title or abstract.
2. The abstract has **been presented at other meetings or previously published**.
3. The abstract is **poorly organized or missing required information** (e.g., diagnostic details, clinical impact).
4. The abstract **exceeds the word count** (maximum 300 words).

5. The **submitted work lacks novelty** or does not add significant value to existing knowledge.
6. The **innovation is insufficiently described** or lacks supporting evidence for its clinical application.

## NOTIFICATIONS OF ACCEPTANCE/NON-ACCEPTANCE

Official notifications regarding the acceptance or non-acceptance of abstracts will be emailed to all presenting authors on or about April 3, 2025.

- Accepted presenters will receive **detailed instructions**, including links to:
  - Upload their final presentation materials (video of oral presentations, pdf of posters, or supporting documents).
  - Confirm and finalize coauthor details.
  - Update scheduling requests/instructions
  - Complete any additional requirements for participation.

### Important Communication Guidelines

- All communication regarding your abstract will be sent via email to the Presenting Author using the email address provided at the time of abstract Submission.
- Please ensure that you enter a valid, long-term email address for the Presenting Author, as all essential notifications, deadlines, and conference details will be sent to this address.
- The Presenting Author is responsible for keeping track of all communications and completing all necessary steps within the provided deadlines.

### Final Decision & Status Inquiries

- **After April 3, 2025**, the placement or rejection of abstracts is **final**, and no changes will be made.
- **Status inquiries before this date will not be entertained.** Please do not contact IODCPC 25 regarding the acceptance of your abstract before April 3, 2025.

## COAUTHOR PRE-REGISTRATION

Coauthors are encouraged, but not required, to register for the meeting. However, **only registered coauthors will receive a certificate of participation, and only abstracts with all authors registered will be published in the ISBN-registered Book of Abstracts.**
